Their journey began with a practical need: to move Enterprise Risk Management (ERM) out of cumbersome spreadsheets. Recognizing the limitations of manual processes, they sought a GRC solution that was truly flexible, scalable, iterative, and aligned with their dynamic business processes

When Elisabeth Quillatre joined as Group Risk & Compliance Officer, she championed the opportunity to look at risk and compliance more holistically. The goal was clear:



- Exceed Expectations by implementing GRC measures effectively to satisfy stakeholders and ensure regulatory transparency and accountability.
- Boost Efficiency to reduce the time spent on dedicated GRC tasks across all lines of defense (LoD).

Rather than building everything at once, they focused on launching fit-for-purpose workflows first, *carefully balancing customization with usability*, and then layering in additional capabilities like complaints, third-party risk, and data privacy management over time.

#### **Lessons Learned**

- Focus on key stakeholders & show early wins
- Reassess organisational structure to allow for effective workflows
- Before customizing, clearly define main objective & core purpose
- Determine how the tool interconnects with existing systems

#### **Overcoming Challenges**

As Vinted built out their ERM program inside Risk Cloud, one of the critical challenges was not just identifying risks, but ensuring those risks were evaluated consistently and escalated appropriately when thresholds were crossed.

To solve this, Vinted *operationalized their risk appetite* directly within their workflows. They established clear thresholds for different risk categories, such as financial impact, regulatory exposure, and reputational harm. When a new risk was assessed, the system automatically compared the impact ratings to these thresholds.

Designing these specific risk acceptance and escalation level workflows was a key part of operationalizing rules. Goda Vaitkevičiūtė, as Group Risk Process Manager, was instrumental in defining and embedding these critical process steps within Risk Cloud, ensuring the logic aligned with Vinted's governance structure. This automation freed up the team from manual monitoring, improved the consistency of risk evaluations, and allowed for quicker, more informed decisions on risk treatment and acceptance

What began as a move away from spreadsheets has become a dynamic, datadriven governance strategy, positioning Vinted's team to manage risk with confidence at every stage of their growth.
